These three abilities are the basic abilities of a teacher in carrying out the learning process with a classroom management skill, in which the teacher creates a conducive and participatory learning climate and controls it if there is a disturbance in the learning process.

The final activity of the learning process is the closing activity, intended to provide an overall picture of what students have learned and the teacher's ability level in the learning process.

The results of the researcher's findings in implementing online learning, the teaching and learning process still needs to be carried out as it should, even though it is not optimal due to several obstacles during online learning. These obstacles include the lack of stability of the signal network from students so that learning is slightly disturbed.
